### **CLINIC INFORMATION**

- 1. This year's district clinic will be held January 28<sup>th</sup> 29<sup>th</sup>, 2022 at Stuart W. Cramer High School, South Point High School, and Forestview High School. **Snow dates February 4<sup>th</sup> February 5<sup>th</sup>, 2022**.
- 2. Clinicians:

  - Middle School Symphonic Band Carrie Lineberger
  - 9-10 High School Band Josh Stevenson
  - 11-12 Senior High Band Dr. Scott Tobias
- 3. If you have a student who cannot attend the clinic, notify Laradon (SHS Students), Cindy (HS Students), Lisa (MSS Students) or Vickie (MSC Students) as soon as possible! (see contact info on first page of this packet.) There is a list of alternates that will be contacted if needed. DO NOT FILL A VACANCY WITH ONE OF YOUR OWN STUDENTS! Also, each student must bring a signed permission form stating that they will attend the entire clinic. Please duplicate these for your students. These must be turned in at registration.
- 4. The clinic fee is \$15.00 per student. Each director must register for your entire group. Please have <u>correct</u> change or a check made payable to NCMEA SCDBA TREASURER. School, Band Booster or Band Director personal check accepted. No checks from individual parents are accepted. Also, be sure to turn in the All-District Registration Form, as this is a requirement from NCMEA.
- 5. Directors are asked to wear their school I.D. Badges during the clinic.
- 6. The clinic concert will be recorded by **White Sound Studios**. DVD's and CD's of the concert will be available for order before and after the performance.
- 7. Each director is responsible for securing housing for his or her students. Hotel information is enclosed.
- 8. Students should dress up for the concert (coat and tie/dress pant, skirt or dress). No uniforms, please.
- 9. All percussionists should bring sticks and mallets from their own school.
- 10. Brass players should bring all mutes.
- 11. Contra-bass clarinets should bring their own stool.
- 12. Please remind students of respect for property, facilities, and equipment.
- 13. Please make every effort to have students at all rehearsals on time. There will be no transportation provided for students at lunch on Friday and Saturday. There are several fast food restaurants available for your students



### Map of Gastonia, Belmont, and Cramerton




## Stuart W. Cramer Campus Map

## Stuart W. Cramer Building Map




